It has been decided that the pilot scheme would initially be implemented at Upazila level.</p> <p>The Scheme Operator (SO) of the SSK will be an implementing agency to manage the SSK piloting.</p> <p>The SO will professionally conduct core SSK operations in the following areas with necessary applications of Information Technology (IT): (i) SSK membership and Health Care management; (ii) SSK claims and finance management; (iii) Provider management and contracting.</p>

Experience, Resources and Delivery Capacity Required	<p>The following experiences are mandatory:</p> <ul style="list-style-type: none"> - At least 10 years of experience related to managing of large public funds in urban and/or rural setting; - Experience with health insurance / health protection schemes and contracting of health care providers. <p>The following experiences would constitute an advantage:</p> <ul style="list-style-type: none"> - Use of smart cards for identification of beneficiaries; - Managing cash and in kind benefits; - Dealing with low income clients. <p>Note: Physical presence in the pilot region (Tangail District) with offices at Upazila level will be required.</p>
